

ORDINANCE NO. 1.5

A REGULATION AND ORDINANCE AMENDING RULE I
OF REGULATION AND ORDINANCE NO. 1.4 PROVIDING WATER
RATES AND CHARGES FOR WATER FURNISHED BY THE WATER
SYSTEM OF RIO LINDA COUNTY WATER DISTRICT

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF RIO LINDA
COUNTY WATER DISTRICT as follows:

RULE 1: Rule 1 of ORDINANCE NO. 1.4 entitled as above
stated, is hereby amended to read as follows:

"RULE 1: The following water service rates and compen-
sation are hereby fixed and established as the rate and compen-
sation to be charged and collected by the RIO LINDA COUNTY WATER
DISTRICT for water furnished by said District, to wit:

Minimum bimonthly service charge based on size of meter:

5/8" x 3/4" meter	-----	\$ 11.00
3/4" x 3/4" meter	-----	11.50
1" x 1" meter	-----	13.00
1 1/2" x 1 1/2" meter	-----	19.00
2" x 2" meter	-----	32.00
3" x 3" meter	-----	54.00
4" x 4" meter	-----	84.00
6" x 6" meter	-----	144.00

to which will be added the following charges for water delivered
for each bimonthly period or fraction thereof:

For the first 2,000 cubic feet, covered by minimum
bimonthly service charge;

For the next 8,000 cubic feet, 15 cents per 100 cubic
feet or fraction thereof;

All over 10,000 cubic feet, 10 cents per 100 cubic
feet or fraction thereof; and

For each living or business quarters under single control
or management in excess of one utilizing the same meter
an additional charge of \$5.00 shall be made.

Bimonthly service charge for standby fire protection
service shall be \$4.00 per inch diameter of pipe.

The above rates apply to service within and for water
furnished to be used in the RIO LINDA COUNTY WATER DISTRICT.

Consumers using water furnished by said District where the services are outside the District, or the water is to be used outside the District, shall pay such additional charge to the rates above specified as may be fixed especially therefor in each instance by the Board of Directors of said District.


This ordinance shall take effect on July 20, 1978 and be in full force from and after said date, but shall be published once in THE WORLD, a newspaper printed, published and circulated in the RIO LINDA COUNTY WATER DISTRICT, within ten days after adoption with the names of the members of the Board of Directors voting for and against the same."

ORDINANCE NO. 1.6

A REGULATION AND ORDINANCE AMENDING RULE I
OF REGULATION AND ORDINANCE NO. 1.5 PROVIDING WATER
RATES AND CHARGES FOR WATER FURNISHED BY THE WATER
SYSTEM OF RIO LINDA COUNTY WATER DISTRICT

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF RIO LINDA COUNTY
WATER DISTRICT as follows:

RULE 1: Rule 1 of ORDINANCE NO. 1.5 entitled as above stated,
is hereby amended to read as follows:

"RULE 1: The following water service rates and compensation
are hereby fixed and established as the rate and compensation to be
charged and collected by the RIO LINDA COUNTY WATER DISTRICT for water
furnished by said District, to wit:

Minimum bimonthly service charge based on size of meter:

5/8" x 3/4" meter	-----	\$ 10.00
3/4" x 3/4" meter	-----	10.50
1" x 1" meter	-----	12.00
1 1/2" x 1 1/2" meter	-----	18.00
2" x 2" meter	-----	31.00
3" x 3" meter	-----	53.00
4" x 4" meter	-----	83.00
6" x 6" meter	-----	143.00

to which will be added the following charges for water delivered for each
bimonthly period or fraction thereof:

For the first 2,000 cubic feet, covered by minimum bimonthly
service charge;

For the next 8,000 cubic feet, 15. cents per 100 cubic feet
or fraction thereof;

All over 10,000 cubic feet, 10 cents per 100 cubic feet or
fraction thereof; and

For each living or business quarters under single control or
management in excess of one utilizing the same meter an additional
charge of \$5.00 shall be made.

Bimonthly service charge for standby fire protection service shall
be \$3.00 per inch diameter of pipe.


The above rates apply to service within and for water furnished to
be used in the RIO LINDA COUNTY WATER DISTRICT.

Consumers using water furnished by said District where the services are outside the District, or the water is to be used outside the District, shall pay such additional charge to the rates above specified as may be fixed especially therefor in each instance by the Board of Directors of said District.

This ordinance shall take effect on August 20, 1978 and be in full force from and after said date, but shall be published once in THE WORLD, a newspaper printed, published and circulated in the RIO LINDA COUNTY WATER DISTRICT, within ten days after adoption with the names of the members of the Board of Directors voting for and against the same."
